Shipping expenses are due at the time of reserving the flight nanny. Type of payment accepted: Venmo/Paypal (through bank account only)/Cash, We also accept credit cards through square with a 3% fee. **NOTICE: DEPOSIT IS NON REFUNDABLE.**

Shipping and Delivery: There are a couple ways you can get your Designer Mountain Mutt baby!

You can come to our home or we can flight nanny your new baby in the cabin of the plane and hand deliver your new baby to your airport of choice. We do NOT fly our new babies in the cargo holding of the plane. This causes too much stress on such a new little one and IMO it's cruel and there are much better options for delivery. We have plenty of experience in transporting our puppies through air travel. We can assure you your new baby will be very well taken care of for this trip. We had to adjust our prices a little to accommodate the rise in expenses of airlines. We provide flight services to major airports at a rate of \$1000. Please note that this fee is due at the time of booking. We are also more than happy to meet you at our two closest airports at our convenience for traveling expenses paid by the client.

We send each of our little ones home with their very first crate and a bag of their familiar food. Every puppy also receives a special gift bag that includes our favorite brush for keeping a Cavachon's beautiful coat soft and tangle-free, a toothbrush, chews and treats, their favorite toy, poop bags, and a probiotic to help settle their tummy after traveling.

Each puppy also comes with a personalized folder containing their pedigree, vaccination record, and a Well Puppy Health Exam signed by our trusted veterinarian. We include a detailed After-Care Packet with our daily schedule and helpful tips to ensure a smooth transition into their new home.

Extended Stay: We send all of our babies home at 8 weeks with their first set of shots and second deworming. We are always happy to extend their stay with us for time beyond the 8 weeks. During this time, we work on basic commands and fully potty training. If there are routine vet visits, such as shots or dewormings, that need to be done during their extended stay with us, those charges would be your responsibility. **Any boarding beyond the 8 weeks, we charge \$150 per week.** This is well below any boarding fees that you would incur boarding your pup with the vet or other dog boarding facility.



Health: The seller states that the puppy that you will be purchasing is healthy at the time the puppy is being taken home. I, the seller, will have your puppy's Well Puppy Health check at our local vet. There He/She will be inspected for any health issues/concerns and be given 1st set of shots and dewormer. I, the seller, will not be responsible for any vet bills once puppy has left my care.

New Puppy Health Guarantee:

All puppies are placed in their new homes without any known contagious, congenital or hereditary illnesses.

First step in guaranteeing your new puppy's health is a trip to the veterinarian's office within the first three days of your purchase, excluding weekends or holidays. (I'm happy to grant an extension upon request and breeder acknowledgement due to extenuating circumstances) Your puppy guarantee will then be effective and you will have peace of mind immediately that you have a healthy puppy prior to building an even stronger bond in the days to follow. This health guarantee is for two years.

What's covered:

If within the two years your puppy is diagnosed with a life-threatening problem such as kidney, liver or heart disease, you can return your puppy for a replacement puppy. I will need a statement from your veterinarian regarding your puppy's life-threatening health issue. Your replacement puppy will be given to you as soon as possible. If you choose to keep your puppy, there will be no reimbursement for medical bills of any kind.

What's not covered:

Non-life-threatening problems such as allergies to certain foods, skin rash, loose stools, etc.

Our goal is to provide you with a healthy puppy that will have a long life free of life-threatening issues. This is why we have put so much time and work into selecting only the best sire/dams for our program. And to follow up on that, we have ALL of the testing done on our dogs to prove that we only want healthy puppies for our clients! All of our dogs are given vitamins/supplements and are properly maintained and observed so they do not become deficient in their needs to be healthy and deliver healthy puppies for you. On occasion, a puppy may develop a Non-life-threatening issue and this can be managed by you and/or your veterinarian. I will not assume responsibility for vet bills and cost of such issues.

Worms and Parasites:

Worms are common in puppies and we deworm our babies routinely as our goal is to send them home free of such irritants. Some may need additional treatment and your vet should check and treat if needed.



Umbilical Hernias:

Every now and then, a puppy may end up with an umbilical hernia. This is usually caused by the cord being chewed off too close to the body. No need to worry, it's an easy fix and can be done when your puppy is spayed or neutered.

Any non-life-threatening issues

- Buyer agrees to have puppy examined by a reputable veterinarian within 48 hrs from the time of taking possession and to have the Veterinarian Examination Report completed by the veterinarian. This report can be texted to (307) 248-3607 or emailed to Designermountainmutts@gmail.com
- If the Veterinarian establishes a MAJOR health problem with puppy, the puppy may be returned at this time. I reserve the right to have the puppy further examined by a veterinarian of my choice before an exchange is made. The buyer is responsible for all return cost and once puppy is received, a full refund of puppy will be made back to the buyer.
- Puppy is guaranteed for 72 hrs from the date and time of delivery against infectious diseases (parvo, corona, or distemper). In event of death of puppy within the 72-hour guarantee period, the buyer will take the deceased puppy to a veterinarian of your choice for the purpose of an
- autopsy at the buyer's expense. The vet must then provide a statement to the seller with cause of death. If natural causes are determined with warrantable condition, a replacement puppy will be provided back to the buyer. However, if trauma or neglect is found to play role in the demise
- of the dog in any manner or fashion, then no exchange will be forthcoming. Additionally, the buyer agrees to hold the seller harmless for such.
- All veterinary expenses, as well as other expenses associated with puppy, are the responsibility of the pet owner once they have taken possession of the puppy.

We have a spay/neuter agreement. Buyer agrees to provide proof of spay/neuter from their choice of veterinarian by 6 months of age. If buyer does not follow through with this spay/neuter agreement an additional \$1500 will have to be paid by the buyer at the puppy's 6 month of age.

Returns: No guarantee is made as to the disposition, confirmation, or breeding ability. Designer Mountain Mutts will not accept returns on a puppy unless it is covered in the health section of this contract. Under no circumstances will any refunds, partial or full, be given.
